#### 4.0 Business Arising from the September 25, 2014 Senate Meeting

#### 4.1 Student Assessment and Evaluation Policy – Linda Dalton

Linda Dalton spoke to the Student Assessment and Evaluation Policy approved at the September 25<sup>th</sup>, 2014 Senate meeting. Committee Members on the Academic Policy Committee discussed wording in the Student Assessment and Evaluation Policy and presented two motions to amend the Policy as previously adopted, with prior notice provided in the call of this meeting.

#### 4.1.1 Motion regarding 4.1 G.

Moved by M. Lysack; seconded by A. Gaston:

THAT Senate amend the Student Assessment and Evaluation Policy 4.1 G. by striking out the words "Assessment and", and striking out the words "should be" and inserting the word "is", to read as follows: 4.1 G. Assessment and e Evaluation information of individual students is should be confidential and is subject to relevant Provincial legislation and statutes.

Carried.

A Senator suggested a minor change to the above in order to correct a grammatical issue.

Moved by H. Simkins:

THAT Senate amend 4.1 G. to read "Evaluation information of an individual student's work is confidential and is subject to relevant Provincial legislation and statutes."

#### 4.1.2 Motion regarding definition of Evaluation

Moved by M. Lysack; seconded by A. Gaston:

THAT Senate amend the Student Assessment and Evaluation Policy definition of Evaluation by striking out the words "qualitative measurement" and inserting "defined criteria (e.g. rubric, grading scheme)", to read as follows: Evaluation: means the determination of the quality of work based upon qualitative measurement defined criteria (e.g. rubric, grading scheme). ## 4.2 October 20<sup>th</sup> Research Visioning Day

The Vice-Chair presented a summary of the recent October 20<sup>th</sup> Research Visioning Day.

The basis for discussion at the Research Visioning Day was the URCA draft White Paper recommendations and the recommendations that were forwarded by the Scholarship of Teaching and Learning (SoTL) Engagement Team as well as other documents. During the Research Visioning Day, conversations took place regarding the complexities of what Undergraduate Research and Creative Activities will mean at Sheridan. The evolution of a variety of definitions and perspectives about what Undergraduate Research and Creative Activities are was discussed. Gerard Puccio conducted an exercise to assist in thinking about metaphors to represent where Sheridan is going. The group then went through a problem solving process where they looked at URCA applying Creative Problem Solving methodology (POINT) via plusses, opportunities, issues, and new thinking. Each of the 13 groups presented their recommendations for a go-forward to address issues that had been identified.

At a future Senate meeting, the Provost and Vice President Academic will bring forward propositions and suggestions of what the initial work plan may look like.

The President advised that two new policies (Advanced Standing Policy and General Education Policy) and two new programs (Bachelor of Mechanical Engineering Degree and Bachelor of Architectural Studies Degree) were approved at the Board of Governors (BoG) meeting on October 22, 2014. BoG also approved the awarding of a contract for further expansion of the Davis campus (to build the new Skills Trade Centre).

The Groundbreaking for the second phase of HMC will take place on Friday, October 24<sup>th</sup>. This will be streamed live on Sheridan's website at 9:30am.
