ANNUAL LOCKER MAINTENANCE/CLEANING

Lockers must be emptied by the user within three days of the end of the winter semester (end of April in a given year). All non-vacated lockers will be emptied by Sheridan Security immediately thereafter. All belongings obtained from lockers will become the property of Sheridan and will be disposed of with no obligation on Sheridan to preserve any property or belongings.

Sheridan's Locker Use Agreement contains the terms of the agreement between Sheridan and Users(as defined in the Locker Use Regulations). Occupation of a Sheridan locker is governed by the terms of the Locker Use Regulations as well as by this Agreement. By signing this Agreement, you agree its terms and the terms of the Locker Use Regulations and you acknowledge that you have read this Agreement and the Locker Use Regulations, available online at lockers.sheridancollege.ca and at the Security Desk. You also acknowledge the receipt and sufficiency of the consideration in executing this Agreement and agreeing to its terms for the privilege of using a Sheridan locker.

Sheridan is subject to the Canadian Charter of rights and Freedoms (the "Charter). Section 8 of the Charter gives all individuals the right to be secure against unreasonable search and seizure. However, use of a Sheridan locker constitutes consent to Sheridan searching your locker where Sheridan holds a reasonable suspicion of wrongdoing relating to the contents of the locker (or in other circumstances as described in the Sheridan Locker Use Regulations). By using a Sheridan locker, you waive all rights you have under section 8 of the Charter as against Sheridan and its employees and/or agents.
