

#### OFFICIAL CONTEST ENTRY RULES FOR SHERIDAN OCAS VOUCHERS

This contest is for prospective students who are applying for admission to The Sheridan College Institute of Technology and Advanced Learning (the "Sponsor") and scheduled to begin their studies during the 2022/2023 academic year, and will be interpreted and subject to Canadian federal, provincial, municipal and local laws and regulations. Void where prohibited. No purchase necessary to enter or win.

"Sheridan OCAS Voucher Contest" (the "Contest") is administered by the Sponsor. By participating in the Contest, each contestant (the "Contestant") agrees to be legally bound by these Official Contest Entry Rules (the "Rules") and acknowledges having read these Rules.

## 1. CONTEST PERIOD

The Contest is run by the Sponsor and will begin on October 18, 2021 at 8:00 a.m. ET and end on February 1<sup>st</sup>, 2022 at 8:00 a.m. ET with one (1) winner announced every Friday in October and November 2021 during College Mondays (the "Weekly Draws"), and 13 winners announced during the Open House taking place on October 30<sup>th</sup>, 2021 from 10:00am ET to 2:00pm ET (the "Open House") (the "Contest Period"). The Sponsor reserves its right to cancel, terminate, modify, amend, extend or suspend the Contest, and to select a winner from previously received applicable eligible Contestants.

#### 2. ELIGIBILITY

To win the Prize (as defined below), the Contestant must, at the time of the draw:

- I. Have completed all requirements listed below in Paragraph 3 How to Enter the Contest.
- II. Be at least 16 years of age. If the Contestant is not of the legal age (i.e. 18 years) ("Minor"), the parent / guardian of the Minor must have read and agreed to these Rules on behalf of the Minor.
- III. Have agreed to comply with applicable laws (including but not limited to libel, and obscenity), assume responsibility for their activities, ant not to harass, disrupt, abuse, or invade the privacy rights of others;
- IV. Have read and accepted, and agreed to comply with these Rules, and with the Privacy and Legal Statement for Sponsor found at https://www.sheridancollege.ca/privacy-legal.aspx.

#### 3. HOW TO ENTER THE CONTEST

- I. Weekly Draws
  - a. Contestants shall fill out the Prospect Card at the following link: <u>https://sheridan.tfaforms.net/34?evtId=a1J6g000007as2M</u> to be eligible for the Weekly Draws with their first registration – multiple registrations will not be eligible.
  - b. Only Contestants who have filled out the prospect card, have come into the Sponsor Room and have attended the Sponsor session after the initial announcements during College Mondays will be entered into the Weekly Draw, subject to compliance with these Rules (as determined by the Sponsors in their sole and absolute discretion).

# II. Open House Draws

- a. Contestants shall register for the Open House event at the following link: <a href="https://www.sheridancollege.ca/admissions/visit-sheridan/open-house">https://www.sheridancollege.ca/admissions/visit-sheridan/open-house</a>, after which Contestants shall receive an email to join the Open House event through Hopin. Contestants are required to create a Hopin account in order to attend the Open House event.
- b. Contestants must attend the Open House event in order to participate in the Open House draw, subject to compliance with these Rules (as determined by the Sponsors in their sole and absolute discretion).
- III. All registrations must include Contestant's first name, last name, e-mail address, and any additional compulsory fields.
- IV. Entries are deemed to be submitted by the Authorized Account Holder of the email address submitted at the time of registration. "Authorized Account Holder" is defined as the natural person who is assigned to an e-mail address by an internet access provider, on-line service provider, or other organization (e.g. educational institution, business, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.
- V. To be considered an eligible entry, Sponsor reserves the right to vet entries based on consistency with Sponsor's policies and procedures.
- VI. No purchase necessary to be considered an eligible entry, but Contestant must follow the participation requirements for the Weekly Draws and / or Open House event to be entered into the Contest.

All entries may be subject to verification at any time. Sponsor reserves the right, in their sole discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor) to participate in the Contest. Failure to provide such proof in a timely manner may result in disqualification. The Sponsor will not be responsible for late, lost, illegible, falsified, damaged, misdirected, mutilated, garbled or incomplete entries, which will be void.

By entering the Contest, submitting an entry and providing your contact information, each Contestant: (i) allows the Sponsor to use the Contestant's name, program, anticipated year of entry, anticipated term and/or e-mail in advertising or other publicity, in any form of media; (ii) agrees to release and hold harmless the Sponsor, its affiliates, advertising and promotional agencies, suppliers of materials or services related to the Contest and all of their respective shareholders, directors, officers, employees and agents from and against any and all claims including but not limited to claims based on publicity rights, defamation, invasion of privacy, copyright infringement, trade-mark infringement breach of contract or any other intellectual property related cause of action that relate in any way to the sharing of this information on any social media channel subscribed to by the Sponsor; and (iii) gives the Sponsor consent to contact them in any way about future Sponsor events, contests and promotions.

#### 4. PRIZES

There are twenty (20) prizes which are available to be won by twenty (20) Contestants (the "Prize Winner"). The Prize consists of Ontario College Application Service (OCAS) Vouchers which cover the \$95

application fee for the August 2022 to July 2023 application cycle and is valid for one year (the "Prize"). Redeeming is subject to the regular operating days of the Sponsor. The Prize shall be planned according to the availability of the Sponsor, at the sole discretion of the Sponsor. All prize winners must be set and/or approved by the Sponsor at the Sponsor's sole discretion. The Sponsor shall notify the Prize Winner that they have won and shall provide to the Prize Winner instructions for receiving the Prize. The maximum value of the prize is \$95.00 CAD. All amounts in these Rules are in Canadian dollars.

The Prize Winner may transfer the Prize to a third party and shall be responsible for any such transfers. The Sponsor may in its discretion substitute the Prize for another prize which is, in its opinion, of equal or greater value. Any additional costs not described in these Rules as part of the Prize that are incurred in collecting and using the Prize are the Prize Winner's responsibility.

The Prize Winner will receive their Prize on Friday, October 22 & 29, Saturday, October 30<sup>th</sup>, Monday, November 1<sup>st</sup>, and Friday, November 5, 12, 19 & 26, 2021.

Additional Prizes may be added throughout the Contest period in which case they will be announced on the Sponsor's social media channels, etc.

#### 5. WINNER SELECTION PROCESS

Twenty (20) winners will be selected via a randomized draw during the Weekly Draws as well as during the Open House event. One (1) Prize Winners will be selected per week during the seven Weekly Draws and thirteen (13) Prize winners will be selected during the Open House event.

The Prize Winner will be notified via e-mail (using the information provided to the Sponsor during the registration processes) and must respond within 48 business hours of transmission or she/he may be disqualified (and will forfeit all rights to the Prize). In the event that Contestant who submitted winning entry does not respond within the 48-hour period, the Sponsor reserves the right, in its sole and absolute discretion, to select an alternate winning Contestant from among the remaining eligible entries (in which case the foregoing provisions of this section shall apply to such new selected Contestant).

The Prize Winner will receive the Prize via e-mail. The odds of winning depend on the total number of eligible entries received.

In order to be declared a Prize Winner or win any Prize, a selected Contestant must, in addition to meeting the Contest eligibility criteria, correctly answer a mathematical skill-testing question without the assistance of any kind, whether electronic or otherwise.

### 6. GENERAL TERMS AND CONDITIONS

I. Prize Winners who have already submitted their application and paid the application fee through OCAS would not be able to use the Prize to get a refund. In this case, the Prize Winner may give the Prize to a third party, subject to Paragraph 4 (Prizes).

- II. The Prizes won during the Weekly Draws are valid for domestic student applicants only since it applies to OCAS applications. Contestants who are international students can participate in the Open House draws. If the Contestant is an international student, and gets selected as a Prize Winner during the Open House draws, Sponsor can waive their international student application fees so long as the application fees have not yet been paid. If the Contestant's application fees have already been paid, the Contestant shall not be eligible for a refund and may transfer the voucher to a third party subject to Paragraph 4 (Prizes).
- III. In the event of any discrepancy or inconsistency between the terms and conditions of these Rules and disclosures or other statements contained in any contest-related materials, the terms and conditions of these Rules shall govern.
- IV. No liability: The Sponsor will not be liable for:
  - a. Any failure of the Sponsor's website, Sponsor servers or other sites (including social media sites) during the Contest or award of the Prize;
  - b. Any technical malfunction or other problems relating to the telephone network or lines, computer on-line systems, servers, access providers, computer equipment or software;
  - c. The failure of any Contest registration or entry to be received by the Sponsor for any reason including, but not limited to, technical problems or traffic congestion on the internet or at any website;
  - d. Any injury or damage to a Contestant's, or any other person's computer related to or resulting from participating or downloading any material in the Contest; or
  - e. Any transfers Prize Winners make to any third party and any resulting occurrences.

## V. Acceptance of Prizes

- a. The costs of everything not specifically stated as included in the Prizes are the sole responsibility of the Prize Winner; and
- b. If the Prize Winner does not utilize any part(s) of his/her Prize, then any such part(s) not utilized will be forfeited in their entirety and nothing will be substituted in their place.
- VI. Termination of Contest: The Sponsor reserves the right, in its sole and absolute discretion, to void any entry and/or withdraw, suspend, amend or terminate this Contest in whole or in part (or to amend these rules) in any way at any time without prior notice (but subject to applicable law), in the event of an error, technical problem, computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure or any other cause beyond the reasonable control of the Sponsor that, in the Sponsor's sole discretion determines, interferes with the proper conduct of this Contest as contemplated by these Rules, or in the event of any accident, printing, administrative, or other error or any kind, or for any other reason. Any attempt to deliberately damage any website or to undermine the legitimate operation of this Contest is a violation of criminal and civil laws and should such an attempt be made, the Contestant will be automatically disqualified and the Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law. The Sponsor reserves the right, in its sole and absolute discretion, and without

prior notice, to adjust any of the dates and/or timeframes stipulated in these Rules, to the extent necessary, for purposes of verifying compliance by any Contestant, entry, or vote with these rules, or as a result of technical problems, or in light of any other circumstances which, in the opinion of the sponsor, in its sole and absolute discretion, affect the proper administration of the Contest as contemplated in these Rules.

- VII. Dispute: In the event of a dispute regarding who submitted an entry, entries will be deemed to have been submitted by the Authorized Account Holder of the email address that was used to submit the entry.
- VIII. Personal Information: By entering this Contest, each Contestant expressly consents to the Sponsor, its agents and/or representatives, storing, sharing and using the personal information submitted with his/her entry only for the purpose of administering the Contest and in accordance with Sponsor's privacy policy <a href="https://www.sheridancollege.ca/privacy-legal.aspx">https://www.sheridancollege.ca/privacy-legal.aspx</a> unless the Contestant otherwise specifies by giving the Sponsor notice in writing.
- IX. Facebook or Instagram Disclaimer: This Contest is in no way sponsored, endorsed, administered by, or associated with Facebook or Instagram or any other social media platform. Each Contestant acknowledges that he/she provides his/her information to the Sponsor. All third parties are completely released of all liability by each Contestant in this Contest.
