# **Official Contest Entry Rules**

THIS CONTEST IS FOR EMPLOYERS WHO ATTEND THE CO-OP & FUNDING SUPPORT EMPLOYER INFORMATION SESSIONS AND WILL BE INTERPRETED AND SUBJECT TO CANADIAN FEDERAL. PROVINCIAL. MUNICIPAL AND LOCAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED. NO PURCHASE NECESSARY TO ENTER OR WIN

"WIN A SPONSORED CO-OP POSITION" (the "Contest") is administered by The Sheridan College Institute of Technology and Advanced Learning (the "Sponsor", "Sheridan"). By participating in this Contest, each contestant agrees to be legally bound by these Official Contest Entry Rules and acknowledges having read the Rules (the "Rules").

# 1. CONTEST PERIOD

The Contest is run by the Sponsor and will begin on February 1, 2022 at 1:00:00 p.m. ET and end on February 3, 2022 at 2 p.m. ET with one winner announced on February 1, 2022 at 1:55:00 p.m. ET, and one winner announced on February 3, 2022 at 1:55:00 p.m. (the "Contest Period"). Contest Sponsor reserves its right to cancel, terminate, modify, amend, extend or suspend the Contest, and to select a winner from previously received applicable eligible Entrants (as defined below).

### 2. ELIGIBILITY

To win the Prize, an organization ("Entrant") must, at the time of the draw:

- have completed all requirements listed below in "How to Enter the Contest":
- (ii) be at least (18) eighteen years of age, an officer of the organization, and a resident of the Province of Ontario to enter the Contest and potentially become a winner of a prize;
- not be an internal department or employee of the Sponsor: (iii)
- (iv) agree to abide by all co-op policies and responsibilities that the Sponsor expects of the Employer:
- (v) have agreed to comply with applicable laws (including, but not limited to, libel and obscenity), assume responsibility for their activities, and not to harass, disrupt, abuse, or invade the privacy rights of others; and

### 3. HOW TO ENTER THE CONTEST:

Participants are only eligible for the Contest with their first registration – multiple registrations, in either the same session or multiple sessions will be ineligible. If an entrant from any organization wins one of the two draws, all other entrants from the same organization are deemed ineligible for all remaining draws. Only those registrants who attend an information session live and are still in attendance for the draws at the end of each session are eligible to win, subject to compliance with these Rules (as determined by the Contest Sponsors in their sole and absolute discretion).

- (ii) All registrations must include your name, organization name, organization address, ten-digit telephone number, e-mail address, and attest that you are an officer for an eligible employer. Entrants who only registered and did not opt-in to the Contest draw or did not attend live are ineligible to be entered into the Contest. Entries shall be deemed to be submitted by the authorized account holder of the email address submitted at the time of registration. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an internet access provider, on-line service provider, or other organization (e.g. business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Illegible entries are ineligible.
- To be considered an eligible entry, the Sponsor reserves the right to vet entries based on consistency with the (iii) Sponsor's Policies and Procedures.
- (iv) No purchase necessary to be considered an eligible entry, but you must opt-in to the draw at the time of registration and attend one of Career-Integrated Learning's Co-op & Funding Support Employer Information Sessions and be in attendance during the draw to win.

All entries are subject to verification at any time. The Sponsor reserves the right, in their sole discretion, to require proof ofidentity and/or eligibility (in a form acceptable to the Contest Sponsors) to participate in the Contest. Failure to provide such proof in a timely manner may result in disqualification. The Sponsor will not be responsible for late, lost, illegible, falsified, damaged, misdirected, mutilated, garbled or incomplete entries, which will be void.

By entering the Contest by submitting an entry and providing your contact information, each Entrant: (i) allows the Sponsor to use the contestant's name, organization, address and/or photographs in advertising or other publicity, in any form of media; (ii) agrees to release and hold harmless the Sponsor, its affiliates, advertising and promotional agencies, suppliers of materials or services related to the Contest and all of their respective shareholders, directors, officers, employees and agents from and against any and all claims including but not limited to claims based on publicity rights, defamation, invasion of privacy, copyright infringement, trade-mark infringement breach of contract or any other intellectual property related cause of action that relate in any way to the sharing of this information on any social media channel subscribed to by Sheridan; and (iii) gives the Sponsor consent to contact them in any way about future Sheridan events, contests and promotions.

# 4. PRIZES

4.1 Prize Package: There are two (2) prizes ("Prize") which are available to be won by two Entrants (the "Prize Winner"). The Prize consists of funding for one Summer 2022 co-op position. Redeeming is subjected to the regular operating days of The Sheridan College Institute of Technology and Advanced Learning. Funding can only be redeemed to hire a Sheridan student in the Summer 2022 work term and all Co-op policies and processes must be adhered to. Funding cannot be used to hire non-Sheridan students, applied to non-Summer 2022 work terms, or for other purposes. The Prize shall be planned according to the availability of the Sponsor and participating vendors at the sole discretion of the Sponsor, including any reporting requirements of the funding. All Prize Winners must be set and/or approved by the Sponsor at the Sponsor's sole discretion. Instructions for receiving your Prize will be given when the Prize Winner is notified that they have won. The maximum value of the Prize is \$7,500.00 CAD. All amounts in these Rules are in Canadian dollars.

The Prize Winner will be required to provide the Sponsor with the following information in order to receive their Prize:

- Name of the Organization
- First, Middle and Last Name of an officer of the organization
- Date of Birth of the officer of the organization
- Contact Information, including:
  - Mailing address
  - o Phone number
  - Email address
  - Finance contact to arrange prize issuance

The Prize cannot be substituted or transferred to a third party and it cannot be exchanged for cash value. However, the Sponsor may in its discretion substitute the Prize for another prize which is, in its opinion, of equal or greater value. Any additional costs not described in these Rules as part of the Prize that are incurred in collecting and using the Prize are the Prize Winner's responsibility.

Prize Winners will receive their prize in one single installment upon conclusion of the Summer 2022 work term. The Prize Winner must provide proof of payment of co-op student wages from the Summer 2022 work term and comply with Sheridan's requests to determine the official reimbursement value to be transferred, with a maximum value of \$7,500.00.

4.2 Additional Prizes: Additional prizes may be added throughout the Contest Period in which case they will be announced on Sheridan's social media channels, Sheridan College TV, etc.

#### 5. WINNER SELECTION PROCESS

Two winners will be selected via a randomized draw of all eligible Entrants in the Contest. One winner will be selected per session. Eligible entrants include those who opt-in to the Contest at the time of registering for the Co-op & Funding Employer Information Sessions and must be in attendance during the session and at the time of the winner announcement.

The Entrant of each winning entry will be notified live during the session and via email and/or phone and must respond

within 48 hours of transmission or she/he may be disqualified (and will forfeit all rights to the Prize). In the event that Entrant won does not respond within the 48-hour period, the Sponsor reserves the right, in its sole and absolute discretion, to select an alternate winning Entrant from among the remaining eligible entries (in which case the foregoing provisions of this section shall apply to such new selected contestant).

The odds of winning depend on the total number of eligible entries received.

In order to be declared the confirmed Prize Winner or win any prize, a selected contestant must, in addition to meeting the Contest eligibility criteria correctly answer, in person, a mathematical skill testing question without the assistance of any kind, whether electronic or otherwise.

#### 6. GENERAL TERMS AND CONDITIONS

  - (ii) any technical malfunction or other problems relating to the telephone network or lines, computer on-line systems, servers, access providers, computer equipment or software;
  - (iii) the failure of any contest registration or entry to be received by the Sponsor for any reason including, but not limited to, technical problems or traffic congestion on the Internet or at any website;
  - (iv) any injury or damage to a contestant's, or any other person's computer related to or resulting from participating or downloading any material in the Contest;

- 6.4 Termination of Contest: The Sponsor reserves the right, in its sole and absolute discretion, to void any entry and/or withdraw, suspend, amend or terminate this Contest in whole or in part (or to amend these Rules) in any way at any time without prior notice (but subject to applicable law), in the event of an error, technical problem, computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure or any other cause beyond the reasonable control of the Sponsor that, in the Sponsor's sole discretion determines, interferes with the proper conduct of this Contest as contemplated by these Rules, or in the event of any accident, printing, administrative, or other error or any kind, or for any other reason. Any attempt to deliberately damage any website or to undermine the legitimate operation of this Contest is a violation of criminal and civil laws and should such an attempt be made, the person will be automatically disqualified and the Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law. The Sponsor reserves the right, in its sole and absolute discretion, and without prior notice, to adjust any of the dates and/or timeframes stipulated in these Rules, to the extent necessary, for purposes of verifying compliance by any contestant, entry, or vote with these Rules, or as a result of technical problems, or in light of any other circumstances which, in the opinion of the Sponsor, in its sole and absolute discretion, affect the proper administration of the Contest as contemplated in these Rules.
- 6.5 Dispute: In the event of a dispute regarding who submitted an entry, entries will be deemed to have been submitted by the authorized account holder of the email address that was used to submit the entry. "Authorized account holder" is defined as the person who is assigned ownership of an email address.
